Terms & Conditions:-

1. The words "Replacement of 80 Batteries" of Delhi Police Public School, B-4, Safdarjung Enclave, New Delhi should be mentioned at the top of the envelope. The same should be addressed to, The Principal, Delhi Police Public School, Safdarjung Enclave, New Delhi-110029.
2. The bids received after scheduled time/date shall not be entertained.
3. Conditional bids will not accepted.
4. The rates should include GST as applicable.
5. The date of manufacturing of batteries shall be within 3 months of supply.
6. The Self-discharge per month less than 3% at rated capacity at 25 °C.
6. The efficiency should be >90% Ah and >80% Ah.
7. The guarantee/warranty shall be minimum 24 months.
8. The packing material (Lid & container) shall be fire retardant.
9. The Make of the supply batteries shall be only **EXIDE**.
10. Bidder shall quote rate for replacement of the old battery with new battery after deducting the buyback price.
11. The vendor must be registered with GST and registration certificate for the same must be attached with the technical bid.
12. No advance payment shall be made at any cost.
13. The bidder shall have to deposit a DD of Rs. 5,000/- only along with the bid in the form of EMD.
14. EMD shall be released only after the completion of warranty/guarantee period successfully.
15. Payment shall be release only after satisfactory report of the committee appointed by the school.
16. **The price quoted by the vendor should include the transportation as well as installation charges or any other hidden charges. Hence, it will be responsibility of the vendor to transport and install the batteries at his own cost. No extra payment shall be made to vendor in this regard. No payment shall be released if the quantity and quality is not found as per specifications.**
17. Specifications and quality of the batteries should be strictly according the bids/requirement.
18. The school management or purchase committee reserves the right to reject any bid without assigning reason.
